Class Council of 2020 Constitution

Article I (Name)

Class Council of 2020

Article II (Purpose)

Our class council exists in order to represent the class of 2020 at school events; to participate in volunteer work; to organize fundraising; to raise money for our Prom.

Article III (Club Officers)

- The Class Council of 2020 board consists of: the President, Vice President,
 Treasurer, Secretary, and 1 STUCO Representative
- 2. The Officers are selected by elections towards the end of the year if the advisor and members deem it necessary for a new board to be chosen. Any candidates have to fill out a form with their desired position and answer the questionnaire regarding why they would like the position/how they would fulfill their duties.
- 3. Each officer has their own duties, besides participating and helping in events. The President presides and directs meetings with the help of the Vice President, who can substitute for the President if need be. The Treasurer works with the advisor in accounting the club's money. The Secretary takes organized notes at each meeting to archive all discussions. The Representatives alternate in attending Student Council meetings on Tuesday mornings to represent; request fundraisers/ other events.

Article IV (Club Members)

- 1. The requirements of being a member are: being a student of the Class of 2020, attending club meetings whenever possible, being able to help with club events.
- 2. Some duties of members include actively participating in fundraising events, such as bake sales and candy sales.
- Member responsibilities include coming to meetings, decorating for Homecoming, participating in Homecoming events, and attending volunteer work if available.

Article V (Club Meetings)

- The Class Council of 2020 meets during Rebel on Thursdays in Mr. Ciccolini's room (Room 222)
- 2. The meetings begin with discussing the agenda and going over events that need to be done.
- 3. There are no dues to join the Class Council, but participating in fundraisers is highly encouraged and expected of all members.
- 4. Committees for events and fundraisers are organized on an as-needed basis. By attending meetings, members can join the committee of their preference.
- 5. Attendance is not mandatory but is necessary in order to stay up to date with the happenings of Class Council. At every meeting there is a sign in sheet.
- 6. Visitors such as the Yearbook club are welcome to visit Class Council meetings to take pictures for the yearbook.

Article VI (Impeachment of Officers)

- A Class Council Officer can only be impeached if he/she is not fulfilling their job and duties, nor participating in events if available.
- 2. The impeachment process will be a vote raised by another officer and an anonymous majority vote by the members at impeachment meeting.
- 3. The accused Officer will be notified of impeachment procedures after receiving a warning and second chance for improvement. He/she cannot be present at the impeachment process, and will be notified of results afterwards by the club's advisor.

Article VII

- 1. Members of the Class Council cannot be expelled.
- 2. If misconduct of a member occurs at any of Class Council events, the member will receive a warning, and if necessary, be asked to leave.
- 3. The member will be notified of their expulsion from the event by an officer or the advisor.
